TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE No. 2018-ROAD

An ordinance levying taxes for all road purposes for Grant Township Road District, Lake County, Illinois for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Grant Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Grant Township Road District on December 18th, 2018 does hereby determine and declare that the sum of Three Million One Hundred Fifty-eight Thousand Five Hundred and 00/100 Dollars (\$3,158,500.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all of the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL ROAD & BRIDGE, SOCIAL SECURITY FUND,

PERMANENT ROAD, EQUIPMENT & BUILDING, INSURANCE,

ILLINOIS MUNICIPAL RETIREMENT FUND,

For the year 2018.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Grant Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


