TAX LEVY ORDINANCE

TOWNSHIP ORDINANCE No. 2018- Town

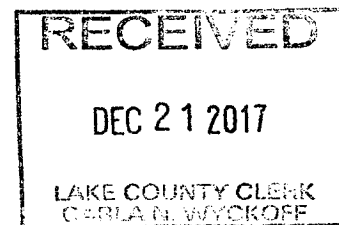
An ordinance levying taxes for all town purposes for Grant Township, Lake County, Illinois for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees, Grant Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of One Million Three hundred seventy-seven thousand and 00/100 Dollars (\$1,377,000.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all of the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL TOWN FUND, SOCIAL SECURITY FUND,
GENERAL ASSISTANCE FUND, LIABILITY INSURANCE FUND,
ILLINOIS MUNICIPAL RETIREMENT FUND,

For the year 2017.



SECTION 2: That the amount levied for each object and purpose shall be as follows:
