### a. Report on Florence Fischer Dinner

### b. Update on Walking Path

Highway Commissioner Kiesgen reported that further work on the path is on hold until spring. The weather has to cooperate so that asphalt and concrete can be poured.

### d. Discuss Playground Equipment for Parks

### e. Clerk Attestation Signature

This will be an ongoing discussion in all townships, as it was the most discussed topic at the TOI conference in November. There are many thoughts about the most effective way to proceed. Our attorney does not call for attestation signatures. However, together we will determine what makes the most sense for Grant Township.

## 10. New Business

### a. Information on the Healthcare Foundation of Northern Illinois

At a public meeting, community members participated in a discussion about medical care in our community. The moderator, Mr. Mike Duffy, asked participants what they felt the immediate and long-term medical needs are and thoughts about a crisis center in the area. All agreed that medical care and a crisis center was a needed asset. This will be an ongoing discussion for our community. Mr. Duffy will return, hopefully with a possible action plan.

### b. American Red Cross Facility Agreement

Grant Township entered into an agreement with the American Red Cross to allow Red Cross the use of our Township building in order to provide services to the community in the event of a disaster.

**c. Report on the Pro Com Fire Alarm System**

We will be looking into updated fire alarm systems that may better suit our needs and securing proposals to consider.

**d. Update on HB4637**

House Bill 4637 is focused on McHenry and Lake Counties and is intended to dissolve a township with services being handled / managed by the county. Additionally, the road districts would be negatively impacted. We are urged to keep in contact with our representatives to prevent these actions.

- we are experiencing an increase from those who are looking for ways to assist
- Volo is proceeding to accept bids for bringing Lake Michigan water to the village

- a quick start for the winter season; lots of snow, lots of ice; had several trees that snapped with the weight of ice
- Big Hollow is considering the use of solar panels. They have enough acreage to accommodate the solar panels. Nothing is definitive at this point.
