8. Miscellaneous

a. Supervisor Starostovic reported that a local Girl Scout had made a Library Book Respository to be placed at Grant Township. A book may be taken and does not have to be returned. Supervisor Starostovic is working with the Maintenance Department for placement of the book Respository.

9. Old Business

a. Building & Grounds Report

Supervisor Starostovic showed the board pictures of damage that had been done by the previous wind storm. A tree had been down, Facia boards from the garage and the Grant Township entrance sign had collapsed due to the rotted wood. Supervisor Starostovic had received a proposal from an electrician to run electricity out to spot where there will be a replacement sign in the future. Supervisor Starostovic advised Board that we would be going out for bid. Trustee Lippert stated that he would like to see an on ground sign installed. Supervisor Starostovic reported that the lighting had been re-installed through the buildings. Supervisor Starostovic reported that the Hydro Block project that had been approved previously would not be done due to the increase in price from original proposal.

b. Update on Walking Path

Highway Commissioner reported that the bike/walking path has been completed. It has been reported that the path is being used a lot by residents. Trustee Lippert inquired if there has been any word on the Path Grant that Grant Township applied for. Supervisor Starostovic reported not at this time.

c. Report on Township Projects

Supervisor Starostovic asked the Board if they would like to do any further projects at this time. Discussion was made regarding the entrance sign and installing the climbing wall at the playground. Trustee Selle asked if there was anything that had to be done with the pond. Supervisor Starostovic reported that there are no problems at this time. The maintenance department have done a wonderful job with the grounds and the park.

Health Insurance With United Health Care \$277,028.99

Highway Commissioner Kiesgen explained the change of insurance coverage for the September 15th renewal. Commissioner Kiesgen stated that the savings in cost to the Township was the main factor of their decision. Commissioner Kiesgen stated that United Health Care policy would provide good coverage to the employee. Trustee Selle and Trustee Lippert addressed some questions regarding the coverage compared to Blue Cross/Blue Shield. Supervisor Starostovic stated that she would like to discuss other options to save money on insurance premiums at a later date.

Trustee Selle made a motion to approve to accept the Health Insurance Coverage with United Health Care with the premium of \$277,028.99 annually; motion seconded by Trustee Hamm.
