# 5. Approval of Minutes

# 7. Approval of Investment Report

#### 8. Miscellaneous

Mr. and Mrs. Callesse who reside on N. Ridge Road in Ingleside came to voice their concerns on numerous ongoing problems impacting their subdivision. Pictures were passed out showing many of the concerns the subdivision is currently facing. The residents have been in contact with Highway Commissioner Kiesgen with their concerns and are awaiting further response from her. The Highway Commissioner was not able to attend tonight's meeting. Many of the Trustees including Supervisor Starostovic voiced their concerns on the problems the neighbors are facing and all are hoping the Highway Commissioner or County can help the neighborhood soon and all are awaiting an update from the Highway Commissioner.

#### 9. Old Business

a. Report on Adopt-A-Family and Christmas Distribution

Supervisor Starostovic reported that this year we did not have as many families requesting assistance as in the past. We are also still handing out the Holiday meals. Supervisor Starostovic thanked all the volunteers who have helped with the distributions for their dedicated hard work.

### b. Building, Grounds and Park

Supervisor Starostovic reported that even though we had some very strong winds with the last storm all of our buildings held up good and that even the Gazebo where the Christmas Float was displayed did not get damaged in the high winds.

# c. Update on Christmas Parade

Supervisor Starostovic reported that our float in the Fox Lake Christmas Parade received the Mayors Choice Award. Clerk Martini, Willie and Dan and herself attended in the Lakemoor Christmas Parade with our float. Supervisor Starostovic thanked all the Officials and the maintenance crew for all their hard work in the parades.

### d. Information regarding IMRF

Supervisor Starostovic informed the Board that IMRF contribution for employees will be going down. Previously the contribution was 8.30% going down to 5.64% with individual member contribution set at \$4.50.

## e. Report on Fox Waterway Agency

Supervisor Starostovic reported that she has received notification from the FWA that their 319 Grant with the Corp of Engineers was finally approved and that they are seeking the contributions from their partners. For the next 2 years the Township and the Township Highway Department will be contributing \$2,500 a year for the next 2 years for a total of \$5.000.

## f. Reminder on Sexual Harassment Training

Supervisor Starostovic thanked all the employees and Officials that have completed their mandatory Sexual Harassment Training and reminded the Board that those who have not yet completed their training, that they have till the end of December to complete it.

### g. Report on Proposed Lake County Trash & Leaf Burning

Supervisor Starostovic reported that the County is still evaluating a county-wide leaf burning ban and that the issue will be coming back to the Public Works Committee in January with possible recommendations on how to handle landscape waste on larger lots.

Fox Lake Lakefront Tax Increment Financing Redevelopment Project Supervisor Starostovic reported that she was a member of recent taxing body board meeting to discuss and vote on support for TIF Districts for the Village of Fox Lake. \*Discuss and Approve Roof Repairs to Garage

Supervisor Starostovic reported that the parking garage roof is over 20 years old and needs to be replaced. There was discussion and the Board agreed that the roof needs replacing and that the motion should include an overage limit. Trustee Fischer made a motion to approve the contract for \$11,785.37 but not to exceed \$14,500 for roof replacement. Motion was seconded by Trustee Lippert. Discussion ensued.
