- **b.** Supervisor Starostovic reported updates to the board regarding the proposed Trail Improvements. Supervisor Starostovic explained that Grant Township may only apply for one grant instead of the two that were previously explained at the January meeting. Supervisor Starostovic stated that it was required for the Open Meeting to be held at this meeting. Trustee Lippert questioned why we cannot apply for the two grants. Supervisor stated she would contact Carissa Smith from Gewalt Hamilton for clarification.

Supervisor Starostovic thanked Highway Commissioner Kiesgen for the snowplowing done. Report was given on the ProCom Box – Fire Alarm in lobby. Company advised that system is getting old and parts cannot be replaced anymore. Supervisor Starostovic is looking into a system that would have a direct line to the Fire Department.

Trustee Lippert inquired about the safe and Supervisor Starostovic stated that the maintenance men are working on it.

Carissa Smith from Gewalt Hamilton called during meeting and was put on speaker phone to give explanation of the two grant application process and that we would only qualify for one. Trustee Lippert clarified the linkage to the path. Ms. Smith stated that the path within the property is what we have applied for.

Supervisor Starostovic continued with her report on the update of the new township sign. Supervisor Starostovic stated that she was going out for bid for an electronic sign. Trustee Lippert stated that he preferred signage on the ground. Trustee Selle commented on the kind of signs he has seen on the poles. Examples were discussed and Supervisor Starostovic asked the board their thoughts on a Grid sign.
