5. Motion to Approve Minutes

7. Motion to Approve Investment Report

Trustee Lippert made a motion to approve the Investment Report in the amount of \$4,230,863.43 dated January 15th, 2021; motion seconded by Trustee Hamm. There being no further discussion or comments, the vote was called:

8. Miscellaneous

Supervisor Starostovic announced Judy Martini as the Township new clerk replacing Barbara Schau who has stepped down. Deputy Clerk Nancy Rogers administered the oath to Judy Martini, as the new Township Clerk. Trustees and Supervisor Starostovic welcomed her.

9. Old Business

- a. Report on Building and Grounds:
- Supervisor Starostovic stated that the water heater replacement completed on Feb. 12th went well. The next needed project is moving the water softener from the storage room into the utility room, which may cost between \$2,000-\$3,000. Supervisor Starostovic commended the Township Road Crews for the great job they have been doing with snow removal and stated they have been working very hard to keep our roads safe.
- b. Update on Easter Event:

Supervisor Starostovic reported that a March 27th date has been selected for the "Drive thru Bunnie Wave" event which will take place from 11:00-1:00 here at the Township office parking lot. The Village of Fox Lake will be partnering with the township as the Village will be supplying the candy and the Easter eggs. The drive thru event will be replacing the Township Easter Egg Hunt. The event will be structured similar to the successful Halloween drive-thru event that the Township had for the children in 2020. The Lakemoor Explorers will be volunteering to do traffic control for the event. The flyers and communication pieces are in the works for the event.

- **c.** Discussion on Tax Rate Objection Complaint from Lake County for the 2019 R.E. Taxes: Supervisor Starostovic reported that she has been in discussion with the Township Attorney and some type of compromise might need to happen on this issue.
- d. Update on the Molidor Rd. Bike Path:

Supervisor Starostovic reported that a payment has been made by the Village of Volo. There is still a shortage of \$4,444 for the project from the Village of Volo, But Supervisor Starostovic stated that the matter is finally settled and that Chicago Title usually holds back 10% title costs. Supervisor Starostovic also commended Highway Road Commissioner Kim Kiesgen and her crew for the great job they're doing keeping the Molidor Road path plowed as many children and adults use the path.

- e. Review letter from a resident on DOJ Complaint on behalf of Grant Township Residents: Supervisor Starostovic stated that the Township received a large packet of information from a resident pertaining to the Chain O'Lakes flooding and that a complaint was filed to the DOJ alleging various operational issues. Clerk Martini stated that she also along with many others received the same packet and that it was turned over to Lake County Storm water Management and the Fox Waterway Agency for their comments on the allegations in the packet.

b. Any Other New Business

- Supervisor Starostovic informed Board about the travel team's usage of ball fields and the need to be fair in allowing teams to play. There is a large numbers of children utilizing fields from the Wauconda area because of all the growth in Wauconda and Volo. Supervisor Starostovic recommended that everyone will need a certificate of insurance for safety reasons and that the land was purchased thru an OSLAD grant and that funding should not be jeopardized and that we are extremely lucky to have such a nice area for the children to play. Football will start March 7th and there is a need to do spring football so the 8th graders have a chance to utilize fields Supervisor Starostovic stated. The first game will be 4/17 and will be played until Memorial Day. The Township usually plans a family day and we will have to watch the usage of fields so that football is no conflict.

Supervisor Starostovic also reported that she had been contacted by Lake County Government on the PPE requirements and also gave an update on the Pop-Up Food Market February 20th which will be held at a new location in front of the Storage facility parking lot on the corner of Rt. 12 & Rt. 134 in Fox Lake.

Supervisor Starostovic also commented that she is recommending that the Northern Illinois Food Bank to cut delivery from 1,000 to 750 at the upcoming food market so there will not be as much food left over as the last few times.

Supersvisor Starostovic also commented on the generosity of Congressman Brad Schneider who has personally given donations every few months to help Grant Township Food Pantry.
