a. Supervisor Starostovic asked the board to add a discussion regarding the accounting at Grant Township to New Business. a. Economic Interest Reminder

Supervisor Starostovic thanked officials for getting their Economic Interest Statement in.

**b.** Discuss Referendum for Garbage Disposal

Supervisor Starostovic reported that she had received a few phone calls questioning the multiple garbage service companies that we currently have in our township. There was discussion regarding prices and wear & tear to the roads. Highway Commissioner Kiesgen reported that she had been investigating this subject and she had attended a meeting to coordinate and was going to work with the Associations. Supervisor Starostovic suggested a survey go out to residents. If there was a change in the service to residents it would have to be done by referendum. Trustee Selle agreed and Trustee Lippert requested more clarifications on how it would work. Supervisor Starostovic and Highway Commissioner Kiesgen responded that they will come back to the board with more information.

c. Update on Proposed Projects

Supervisor Starostovic reported that the Grant Application for the Trail has been submitted. Bids for the installation of stairs and insulation in the garage have been requested. Supervisor Starostovic has been in discussion with Team REIL, Inc. regarding additional work done at Everbreeze Park.

d. Discuss Flood Plain Areas in Park

Supervisor Starostovic discussed Gewalt Hamilton Associates, Inc. report regarding Wetland Delineation: Field of Dreams and if the areas that are not in flood plain should be cut. Truste Lippert questioned if there was endangered species threat. Trustee Lippert gave a recommendation for Integrated Lakes Management in Waukegan for possible treatment. Trustee Hamm stated that this should be done. Supervisor stated that this would give us mo space. Trustee Selle stated that this should be done in November. Trustee Lippert stated the we need a game plan.

e. Discuss Pro Com System Replacement

Supervisor Starostovic reported that Pro Com suggested that we need an updated replacement. The second bid that was submitted advised to use until system dies. The consensus with the board is to wait.

The board approved to start with the transformation to the new system and to contract with Ms. Andrus.

Discussion was made on how the departments were handling the situation. Assessor Barr reported that she had received information on how to handle the working situation from other Assessor offices and her department would be taking their workload and work from home. Employee Ralph Schultz wasked how the General Assistance cases were being handled. Also Mr. Schultz reported that the Transportation was running one vehicle at a time and the drivers are sanitizing after use. Supervisor Starostovic stated that there were set hours for the Food Pantry pickup. Highway Commissioner Kiesgen stated that she had set up a safety procedure with her staff.

Supervisor Starostovic and Highway Commissioner Kiesgen discussed the Playground and t Parks being closed. Signs had been put up that the Parks were closed until further notice bu residents have still been using them. It was reported that the State closed State Parks and the Forest Preserves have closed their shelters. Trustee Lippert stated that kids need to be outside. Supervisor Starostovic stated that Federal government says that no more than 10 parties in a group and the State said no more than 50 people in a group. The Board agreed to keep the Park Closed sign up.
