9. Old Business:

a. Building, Grounds & Park Report

Supervisor Starostovic reported that staff has been very busy taking care of the outside grounds and that it looks very nice and that they are doing a great job on maintenance.

b. Update on Park Grant

Supervisor Starostovic reported that there will be a meeting next week with the consultant and that a representative from Water Odyssey to talk about the project.

c. Set Date for Budget & Appropriation Hearing 2022-2023 Supervisor Starostovic polled the board and everyone agreed to June 21st, 2022 at 5:30 PM.

d. Report on Future Community Events

Supervisor Starostovic stated that Deputy Clerk Nancy Rodgers has been busy scheduling upcoming events. On June 8th there will be a trip to the Four Winds Casino. On June 16th there is a trip to Fireside to see Viva Las Vegas in Fort Atkinson. On July 14th the annual Senior Picnic will be held. Our annual Fall Festival will be held on October 2nd, and more to come.

10. New Business

Supervisor Starostovic updated the board on the tractor repairs and that it has been back for repairs 5 times now and still not running right and that it may be time to look into purchasing a new one. She will look into a trade-in allowance and a proposal on new tractor and report back to the board.

11. Officials' Reports

Supervisor Starostovic reported that there are some new applications for more short term rentals in the Village of Fox Lake and that she has concerns. Assessor LaMantia stated that she has a meeting coming up with Donavan Day from the Village of Fox Lake to discuss tax implications for the short term rentals and will keep us informed.

Assessor LaMantia also reported that she is working on a 4 page e-newsletter which explains the taxing process and what taxing bodies receive in percentages of your tax bills. She reported that her books need to be turned in by June 15th to the County and that staff have been very busy.

Trustee Selle reported on the waste hauling agreement that the County took out with Groot and that there are a lot of unhappy residents. He also reported on what a great time he had at lobby day and that he and Supervisor Starostovic were able to see some of our legislators.

Clerk Martini reported that early voting is starting at the County Building on Thursday as well as the vote by mail ballots can start being mailed. She also reported the hours of operation for our extended hour early voting polling place here at the Grant Township Center.

Resident Charlie Buschick came to meeting to follow up on his inquiry about the battery powered radar speed signs similar to the one that Fox Lake had on Rt. 12. Supervisor Starostovic handed out information about the company, Radarsign which supplies these types of signs and suggested that we follow up with the Highway Commissioner to see if that is something she would like to pursue in the township to help control speeding.
