a. 5k Report

It appears that we raised \$3200 at the 5K event. It was a perfect day and the turnout was great. We noted that participants are generally registering online, and registration the day of the event was low.

b. Building, Parks, Grounds Report

- We continue to look for new/different opportunities for the turf and playground area.
- This past month we had to make a fence correction at Field 1; nothing serious.
- We are so proud of our outside staff; they put their heart and soul into keeping our park pristine.

c. Fall Festival

This is coming along nicely. Our vendors are in place, we have just added a few more spots that could be filled. We have added some new entertainment, new crafters and look forward to a terrific day. Last year the event had to be cancelled due to inclement weather; we have a PlanB for this year, in the unlikely event that the weather does not cooperate. It would involve using Grant High School. We are confident it will be another great success.

d. AAHAA

AAHAA is an Antioch non-profit charity, intended to provide access to health care in various local communities. One of their key components is the 'ask a nurse' feature; the goal being to assist and direct those in need to the services best suited to their particular needs. The organization is asking for local monetary participation from the townships and the villages (Lakemoor, Volo, Round Lake, Fox Lake, Grant Township) in order to secure a grant, and ultimately, have a larger reach into the various communities. Grant Township is uncertain about participating in the organization, given that we too provided services to those in need. It appears that it may be a duplication of services. Supervisor Starostovic is going to explore further and have a conversation with those communities that may already be participating in AAHAA in order to determine if participation in this program would be the right move for Grant Township.

211 is another organization now providing assistance to Lake County. This is a phone service, simply phoning 211. A caller will speak with an individual who can provide information and assistance regarding housing, food, health family, etc. This is sponsored by United Way. The calls will be answered in California, and once a callers zip code is determined, they will then be directed to local services that will assist. Grant Township is very connected to the local United Way and given that 211 would use the United Way data base, this opportunity does not appear to add anything to the services that we already have and use.

In order to resolve this issue, Supervisor and board members will request to be on the next board meeting agenda, and attend the meeting.

Ms. Kiesgen reported that the rainy weather has been problematic. The creeks and lakes have as much water as they can hold, and some of the run-off has been difficult for some areas and their homes. The highway team has been busy assisting those who needed help with the water.
