- Supervisor Starostovic reported on the landscape job done by Salinas Landscaping and that there was extra work done by their company. Also Salinas Landscaping would be installing two more trees.

- Highway Commissioner Kiesgen reported that there was a bid opening for Tanneron Bay – Camp Aqua in August. The bid was awarded to Chicagoland Paving Contractors, Inc. for the total amount of \$277,200.00.
