

**JOINT DECENNIAL COMMITTEES: GRANT TOWNSHIP.**  
**& HIGHWAY DEPT. MINUTES FEB. 20, 2024**

SPECIAL MEETING AT THE GRANT TOWNSHIP CENTER AT

1. **CALL TO ORDER:** Meeting was called to order at 5:02 PM by Supervisor Starostovic

4. **DUTIES of COMMITTEE MEMBERS.**

Supervisor Starostovic turned meeting over to Clerk Martini, who asked the Committee Members if they fully understood the duties of the Members and if they had any additional questions. The general consensus was that they understood and had no additional comments and thanked Jennifer Vackar Township General Assistance Case Worker, for all her hard work on report.

**9. FUTURE MEETINGS**


