9. Old Business

a. Updates

- Reminder that the Annual Fish Fry will be held March 9, 2018. Supervisor Starostovic, Trustees Hamm, Selle, Ulasy and Lippert all offered their services at the Fish Fry. Board was reminded to turn in their Super Raffle tickets and there are more tickets available if needed. We have not received word yet if there will be any Kohl's Volunteers.
