### 9. Old Business

### a. Building, Grounds & Parks Report

- the generator is all in place, we are waiting for Nicor to do the connection
- the grounds crew is keeping up with the work; everything is growing fast and it is in need of attention; fields look good
- Supervisor Starostovic is reviewing proposals for switching to LED lighting
- we expect the shelter to arrive the first week of July; once we look at the plans we will determine if we can do it in-house or if we need to go to the outside; we need to keep this project rolling and get it installed
- we need some catching-up and measuring at Everbreeze Park to finish this project
- As a reminder, our 5K is August 26th, followed by our Fall Fest, October 7.

# b. Update, Molidor Road Walking Path

The Safe Route to School part of the path is coming along well. There will be a meeting in the coming week to identify next steps, to keep the project moving, and complete this portion of the path.

The Molidor Rd. path project, from the township entrance up to the existing path to Route 12, remains problematic. We still do not have approval from a local resident, and that needs to be resolved so the project can move forward. Additionally, we now need to extend the culvert to accommodate the bike path. The culvert is in need of reconstruction, and it appears that we will be short of funds. We will look for sources for additional funding. Highway Commissioner Kiesgen would like to have the project completed by October.
