## 9. Old Business

### a. Update on Building, Parks & Grounds

Supervisor Starostovic reported that Nicor Gas Company has moved the gas pipe and all went well and that we are ready to continue on the Walkway path installation. Highway Commissioner Kiesgen stated that the plants are not open for material yet to start the work but it should be shortly.

b. Commissioner Kiesgen presented to the Board the proposal for the Molidor Road Curb installation. The proposal is for \$36,937.50. The Board is in agreement that the curbs are a safety issue and to help stop the erosion on the pathway.

Trustee Lippert made a motion to accept the proposal of \$36,937.50 for the curbs along Molidor Road walking/bike path from Township driveway west to the creek; motion seconded by Trustee Selle. There being no further discussion, the vote was called:

Supervisor Starostovic stated that the work on the creek located on Molidor Road was looking great. Highway Commissioner Kiesgen said that the work was being completed by a Grant and was needed in order to install the culvert.

Supervisor Starostovic stated that the equipment that was ordered for Everbreeze as well as the Field of Dreams would be delivered this week. Also some pieces to repair broken parts on the playground would be arriving. Supervisor Starostovic also stated that installation of the new equipment should be started this week. Supervisor Starostovic reported that she has been discussing with the maintenance department to install loft area in the garage for storage. Supervisor Starostovic will be getting an estimate on insulation for the garage also.

## **12. Audience**


