d. Discuss Sexual Harassment PA100-0554

A new law, Public Act 100-0554 requires all local governments to take formal action to adopt sexual harassment policies. Within 60 days, each government entity must adopt an ordinance or resolution establishing a policy that prohibits sexual harassment. After a brief discussion, Supervisor Starostovic indicated she would check with TOI, other supervisors, and our attorney to ensure that Grant Township is in compliance with the new law.

e. Football Field Update

The president of the Grant Jr. Bulldogs emailed Supervisor Starostovic reporting that there had been an injury on the field sidelines, most likely caused by the asphalt and benches. The board agreed that we should not hesitate to remove these obstacles for the safety of all concerned. In addition, we should probably also ask for full reports when something out of the ordinary does occur on the field.
