9. Old Business

- a. Building and Grounds Update
- Supervisor Starostovic showed pictures of the Grant Park from the current week following the torrential storm; it was the first time that the park had seen this much water
- There has been a problem with the electrical box in that water is somehow coming through it. The conduit is old and rusty; much is due to leakage. Supervisor will continue to followup with this.

b. Walking Path Report

There was no report this month; plans continue to proceed.

c. Everbreeze Report

Supervisor thanked Highway Commissioner Kiesgen for a job well-done at the park. It is looking very good. As soon as we dry out from rain and floods, the basketball court will be striped.

d. 5K Walkers, Workers and Volunteers

The walkers have begun to register, we have workers for the event, and have applied for volunteers from the Kohl's Volunteer Program. We will be ready on the day of the event. We are using a new vendor for the t-shirts, out of Wauconda and we are finishing the sponsor list.

e. Fail Festival at Grant Township

This event is well underway. We have vendors, entertainment, etc. and we will be ready!

- f. Future projects
- We are reviewing bids for the back field fence for Field 4
- We have secured a proposal for a generator. The proposal provides for 3 options; a high end, a middle of the road and a low end. It appears the middle one will best suit our needs. If we complete this project in 2 stages we can save a little money.
- There are many options available to us that are well within our means, and we have the space for options. Some ideas might include a Putting Green, perhaps a BocceBall space; a Horseshoe pit and other ideas.
- We continue to look for options for our proposed shelter at the playground. Metal would be ideal because the maintenance is minimal. The product has a good warranty. We could actually use 2 at the playground; one big and one smaller.

a. Township Officials of Illinois Conference

The date of the conference is November 12-14. There will be a new setup, and some changes as to how the activities are laid out. The agenda will be available shortly. Everyone should try to attend.

b. Discuss Health insurance

We are expecting a 15-20% increase in our insurance. Due to time constraints, we will table this until next month's meeting.

c. Discuss Grant Township Bus Service

Ralph Schultz (Grant Township Transportation Coordinator and Supervisor Starostovic have been strategizing how to best provide transportation services to our residents. Bus service is being looked at for a reduction of 1 bus.

d. Any Other New Business

- Supervisor Starostovic passed out a biography about John Schmitt, a Grant Community High School graduate. She urged everyone to read about an amazing young man.
- The Clarke report indicated that there was no indication of the West Nile Virus

11. Officials' Reports

Highway Commissioner Kiesgen

- The storm and resulting flooding has meant many extra hours for the highway department. Sandbags were filled for not only the township but the team assisted the village as well. Highway Department placed an order for 10k more sandbags. In addition, the wind and microburst that came through took down trees and added to the flooding situation.
- The heavy rain exposed many sinkholes, which can be extremely dangerous.
- Highway Commissioner Kiesgen stated she and the highway department staff were very grateful for the volunteers that helped with whatever tasks were necessary.
- Highway Department is doing whatever is necessary to be helpful to the residents; generators, dumpsters, pumps, are a few of the resources that may be required. It is almost too early to determine what the exact needs are, but we will be responsive.
- The Township and Highway Department were made aware of an opportunity provided by the District 1-F Lions clubs. They can provide a grant up to \$10k. for services and needs that may not be covered by other resources. Commissioner Kiesgen has the application and will explore what void we may have that can be filled by the Grant. Commissioner Kiesgen is closest to the situation and will be the point person for this opportunity and provide a short list to the Lions. The township is very appreciative for the opportunity and the many benefits to our community.
