The Board of Town Trustees met at the Grant Township Administration Building at 26725 W. Molidor Road on June 20, 2017.

Ms. Kay Starostovic acting as chairperson and Barbara Schau as clerk, the following official business was transacted:

**1.-2. Call to Order**

The meeting was called to order at 7:00pm with the pledge to the Flag.

**3. Roll Call of Officials**

Present: Trustees Hamm, Selle, Ulasz; Supervisor Starostovic

Absent: Trustee Lippert (recovering from surgery)

Also present: Clerk Schau, Highway Commissioner Kiesgen, Assessor Barr

**4. Audience**

Ms. Renee Holm, representing the Remington subdivision association, was present and requesting information on the status of the Molidor Rd. path. The topic was on the agenda under Old Business, however the discussion ensued at this point. Highway Commissioner Kiesgen, the point person on this project, updated the actions taken thus far by the various participating entities, and explained the route of the path.

- Volo has gone out to bid for the path between route 12 and Middle Fork on the south side on Molidor Rd. The Volo board will have to approve the bid prior to proceeding.
- The Remington path will be constructed from the Fischer property to the entrance of the Grant Township Administration Building driveway on the east. Grant Road District will build this portion.
- Grant Road District will also be responsible for the Safe Route to School path that will extend from the Grant Administration Building to the intersection of Wilson and Nippersink.
- Another portion of the Safe Route to School will be built by Grant Township/Road District from the Intersection of Wilson & Nippersink to the boundary of Grant Township and Round Lake.
- The last planned portion of the path will eventually be from the intersection of Molidor and Fish Lake south to the Marl Flat Forest Preserve.

Ms. Holm thanked the board for the information.

**5. Motion to Approve Minutes**

Trustee Selle made a motion to approve the minutes from the May 16, 2017 meeting; motion seconded by Trustee Hamm. Supervisor Starostovic made a correction to a date in the minutes and Assessor Barr corrected a percentage in her report. There being no further discussion, Trustee Selle made a change to his motion to approve the minutes with corrections, again seconded by Trustee Hamm. The vote was called:
