### a. Dave McArtin

Mr. McArtin is a volunteer with the US Coast Guard Auxiliary serving the Chain Of Lakes region. The primary mission is to encourage safe boating and offer education for water and boating safety. In conjunction with Safe Boating Week, the week prior to Memorial Day weekend, the U.S.C.G has asked Grant Township to proclaim and endorse safe boating on the chain throughout the season.
