## 11. Officials' Reports

Trustee Lippert:

Thought the annual conference was very good. There was plenty of opportunity to network with other Township Officials throughout the state. The seminars were well-attended and there was plenty from which to choose. Of particular interest was the session on Intergovernmental Agreements. The dinner was good, too.

Clerk Schau:

Expressed how proud she was of our Agendas and Board Minutes. Samples of these from other townships were shared and without a doubt, ours look and read quite professional. Also important was the frequent discussions throughout all TOI participants regarding the new law of attesting signatures. It was clear that there is no single solution to this issue. Some feel an omnibus approach would suffice; others feel individual attesting is the way to go. Clearly this issue will continue to be discussed throughout TOI, with, hopefully, a single resolution. We discussed annual updates to FOIA and OMA requests. We will be receiving updated information and links that will be useful to keep current.

Trustee Selle:

Summarized the event as very valuable. There were terrific networking opportunities, and the breakout sessions were well attended. Also, Trustee Selle noted that one of the most attended sessions was the Cannabis! Session, and the participation in the discussion of legal Cannabis in Illinois. Like most topics, it is full of pros and cons.

Trustee Hamm thought the event was well attended, the breakout sessions were good, and like the opportunity to meet with other officials.

On another topic, Trustee Hamm complimented Ralph Schultz, the Township transportation coordinator, and his drivers, and the terrific service they provide.
