a. Lifeline Screening – the mobile unit will be at the township on January 5, 2012. It is open to the community, for a fee, and with an reservation.

b. Dental Insurance – The township received a proposal from Guardian Dental, the township's dental insurance provider, extending the current policy to cover implant surgery for all employees who are currently covered under the existing dental insurance policy, at a total cost of \$58.96 per month.

13. Officials' Reports

a. Supervisor –

- Molidor & Rt. 12 Intersection: Burnell Russell, Volo, forwarded a copy of the response he received from the Illinois Dept. of Transportation regarding improvements to this intersection. It is currently budgeted for fiscal year 2012-2017. In light of the recent fatality, the IDOT will take steps to advance the project.

- Big Hollow Focus Groups; 4 attended from the township, and all felt it was a very successful session

- Pedestrian Bridge – Supervisor had a recommendation to not treat the wood for 1 year; next fall would be ideal. There was discussion about opening the curb at the base of the bridge to have full access without a step-up from the parking lot. Supervisor will secure a proposal for the most effective and efficient way to handle.

- Strategic Plan – a list of names, addresses and contact information will be ready for the November 2, 2011 meeting

- Tuesday December 27 is the filing deadline for the Levy and the county office will be closed the day before, Monday December 26, 2011. We will need to begin to work in levies asap to meet the deadlines.

- Copies of the notices to the newspapers should also be placed in trustee mailboxes so everyone has a copy of special notices

- Kim responded to Sheila Kennedy concerns

- A copy of the Clark report is in your packet

- the Fox Lake Christmas Parade is Saturday, November 26, 2011; we have always participated;

- Senior Fair is October 27th at Maravela's; township will have a booth there.

- High Rollers trip to Hammond, Horseshoe Casino was a well-attended trip. Hope to have another trip before the holidays. These trips are self-paid by the participants.

- The Movie in the Park was a great success; the weather cooperated so turnout was good; Jr. Bulldogs provided the popcorn

- The cost for the Pedestrian Bridge project: \$398.00 for the permit, and \$4347.95 to build. The total cost came in under our \$5,000 budget. A contractor estimated that the bridge has a replacement value of approximately \$12,000.00.

- Township received thank you notes from the Kubalanza family and the ADAD Radio Players group who used our meeting room for a fund-raiser for this serious disease (UMDF) in the name of Team Haley.

b. Highway Commissioner;

- Meyers Bay will be blacktopped
- Sullivan Lake Rd will be on hold until next spring
- Oakhurst subdivision; on hold until next spring
- Received award for Stanton Point project; impressed with the updated look

c. Assessor

- assessments will be mailed tomorrow, and be published in the Lake County Journal on Thursday; the deadline for appealing assessments is November 21, 2011
- hoping the township and highway department will consider the current economic situation and be modest when working on the levies. Residents can't continue to pay the enormous property taxes.
- asking everyone to try to do more with less
- appeals can be handled at the township level and not have to go to the county. Other townships have experienced increases up to 300% in the number of people appealing
- county has a different process this year; it may not be as hands on as the township process
- it is up to the people of the township to take their concerns and complaints to the state and the county; the levying bodies will only look out for their own interests, not the residents
- consensus that it will continue to be difficult for our residents; our county is the highest taxing county in the Midwest
